

Workforce Summary Document prepared by the State Auditor's Office.
Based on information **self-reported** by the agency, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation decreased by 18.3 percent to 37.6 FTEs in fiscal year 2012 compared to fiscal year 2011. Compared to fiscal year 2008, the agency saw a decrease of 5.3 (12.7 percent) in the total number of FTEs.




Employee Turnover^a


Excluding interagency transfers, the turnover rate within the agency (5.1 percent) was lower than the statewide turnover rate (17.3 percent) and lower than the turnover rate of Article V agencies (18.9 percent) during fiscal year 2012. The fiscal year 2012 agency turnover rate including employees who transferred to another state agency or higher education institution was 15.4 percent.



Compensation Information^a

The average agency salary in fiscal year 2012 of \$46,279 represented an increase of 7.3 percent compared to the average agency salary in fiscal year 2008. In fiscal year 2012, 73.2 percent of employees were paid below the salary range midpoints in which they were assigned; and expenditures for salary and benefits were lower compared to fiscal year 2008.



Agency Job Classifications





In fiscal year 2012, the majority (64.8 percent) of employees were classified in the following job titles: Program Specialist (30.1 percent), Administrative Assistant (13.5 percent), Accountant (7.7 percent), Investigator (7.1 percent), and Director (6.4 percent).

Fiscal Year 2012 Workforce Demographics^b



On average, employees at the agency were 51.6 years of age and had 6.5 years of agency length of service. Of the agency's employees, 84.6 percent were 40 years of age or older, and 52.6 percent had fewer than 5 years of agency length of service. The Employees Retirement System estimates that between fiscal years 2012 and 2015, 20.5 percent of the agency's workforce will be eligible to retire (based on fiscal year 2012 data).

Survey of Employee Engagement^c

The Survey of Employee Engagement, administered by The University of Texas at Austin, is an instrument that measures employees' job satisfaction and employees' perceptions of the effectiveness of the agency. Scores range from 1 to 5, with 5 being the highest. The agency did not participate in the most recent survey cycle.
