
Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 8.0 percent to 692.0 FTEs in fiscal year 2012 compared to fiscal year 2011. As of August 31, 2012, 19.4 FTEs were administrator positions. The institution's 1,119.6 total FTEs represents a decrease of 31.7 (2.8 percent) in the total number of FTEs since fiscal year 2008. Prior to fiscal year 2012, FTE data was reported with Texas A&M University - Central Texas (770).

In fiscal year 2012, 52.0 percent of FTEs were paid from non-Treasury funds. This is an increase of 26.4 percent in FTEs paid from non-Treasury funds since fiscal year 2008. Only FTEs paid from Treasury funds count against the FTE limitation.




Employee Turnover^a

In fiscal year 2012, the total turnover rate for the institution was 12.0 percent. This was lower than in fiscal year 2011, when the total turnover rate was 13.3 percent. The turnover rate in fiscal year 2012 for administrators (15.1 percent) was higher than in fiscal year 2011, turnover for faculty positions (9.9 percent) was lower than in fiscal year 2011, and turnover for staff positions (13.1 percent) was lower than in fiscal year 2011.


Turnover Rates




Administrator Separations

Staff Separations




^a Turnover information is self-reported by the institution. Administrator positions include officials holding titles such as president, vice president, chancellor, associate chancellor, assistant chancellor, dean, associate dean, assistant dean, and positions with similar responsibilities. Faculty positions include all professor, associate professor, assistant professor, instructor, and lecturer positions. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.

Compensation Information^b


The average salary for staff employees increased by 1.3 percent and for administrators it increased by 0.5 percent when compared to the average salaries in fiscal year 2011. Compared to fiscal year 2008, salary and benefits expenditures decreased by 10.4 percent.

In fiscal year 2012, the president's salary was \$265,000. Of that amount, approximately 24.9 percent (\$65,985) was paid from Treasury funds. This salary was unchanged from fiscal year 2011, when the president's salary was \$265,000 (approximately 24.9 percent from Treasury funds).


Administrator and Staff Average Salaries




Of the institution's administrators, 100.0 percent were 40 years of age and older, and of the institution's staff employees, 67.0 percent were 40 years of age or older. The average length of employment at the institution for administrators was 19.9 years, and for staff employees it was 9.5 years.

In fiscal year 2012, 49.9 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.


Age: Administrator and Staff

Data for faculty merit increases includes all professor, associate professor, assistant professor, instructor, and lecturer positions. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.
