
Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation increased by 7.7 percent to 591.2 FTEs in fiscal year 2012 compared to fiscal year 2011. As of August 31, 2012, 85.0 FTEs were administrator positions. The institution's 1,473.1 total FTEs represents an increase of 43.4 (3.0 percent) in the total number of FTEs since fiscal year 2008.

In fiscal year 2012, 49.2 percent of FTEs were paid from non-Treasury funds. This is an increase of 21.1 percent in FTEs paid from non-Treasury funds since fiscal year 2008. Only FTEs paid from Treasury funds count against the FTE limitation.




Employee Turnover^a

In fiscal year 2012, the total turnover rate for the institution was 11.4 percent. This was lower than in fiscal year 2011, when the total turnover rate was 12.7 percent. The turnover rate in fiscal year 2012 for administrators (24.2 percent) was lower than in fiscal year 2011, turnover for faculty positions (17.3 percent) was higher than in fiscal year 2011, and turnover for staff positions (9.1 percent) was lower than in fiscal year 2011.


Turnover Rates




Administrator Separations

Staff Separations




^a Turnover information is self-reported by the institution. Administrator positions include officials holding titles such as president, vice president, chancellor, associate chancellor, assistant chancellor, dean, associate dean, assistant dean, and positions with similar responsibilities. Faculty positions include only tenure-track or tenured professor, associate professor, assistant professor, and instructor positions. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.

Compensation Information^b


The average salary for staff employees increased by 2.7 percent and for administrators it increased by 1.8 percent when compared to the average salaries in fiscal year 2011. Compared to fiscal year 2008, salary and benefits expenditures decreased by 2.7 percent.

In fiscal year 2012, the president's salary was \$311,783. Of that amount, approximately 21.2 percent (\$66,098) was paid from Treasury funds. This salary increased from fiscal year 2011, when the president's salary was \$304,179 (approximately 21.7 percent from Treasury funds).


Administrator and Staff Average Salaries

In fiscal year 2012, the institution used Treasury funds to pay for 54.9 percent of administrator merit increases, 99.1 percent of faculty merit increases, and 55.2 percent of staff merit increases.




Of the institution's administrators, 97.7 percent were 40 years of age and older, and of the institution's staff employees, 52.0 percent were 40 years of age or older. The average length of employment at the institution for administrators was 10.7 years, and for staff employees it was 9.0 years.

In fiscal year 2012, 63.6 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.


Age: Administrator and Staff
