

# 763 - University of North Texas Health Science Center at Fort Worth


Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.

## Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation increased by 5.5 percent to 718.6 FTEs in fiscal year 2012 compared to fiscal year 2011. As of August 31, 2012, 143.6 FTEs were administrator positions. The institution's 1,475.5 total FTEs represents an increase of 258.5 (21.2 percent) in the total number of FTEs since fiscal year 2008.

In fiscal year 2012, 54.2 percent of FTEs were paid from non-Treasury funds. This is an increase of 47.3 percent in FTEs paid from non-Treasury funds since fiscal year 2008. Only FTEs paid from Treasury funds count against the FTE limitation.




## Employee Turnover<sup>a</sup>

In fiscal year 2012, the total turnover rate for the institution was 20.5 percent. This was higher than in fiscal year 2011, when the total turnover rate was 18.6 percent. The turnover rate in fiscal year 2012 for administrators (16.7 percent) was higher than in fiscal year 2011, turnover for faculty positions (13.2 percent) was lower than in fiscal year 2011, and turnover for staff positions (23.5 percent) was higher than in fiscal year 2011.


### Turnover Rates




### Administrator Separations

### Staff Separations





## Compensation Information<sup>b</sup>


The average salary for staff employees increased by 3.3 percent and for administrators it increased by 3.0 percent when compared to the average salaries in fiscal year 2011. Compared to fiscal year 2008, salary and benefits expenditures increased by 12.7 percent.

In fiscal year 2012, the president's salary was \$904,562. Of that amount, approximately 7.3 percent (\$66,033) was paid from Treasury funds. This salary was unchanged from fiscal year 2011, when the president's salary was \$904,562 (approximately 7.3 percent from Treasury funds).


### Administrator and Staff Average Salaries


In fiscal year 2012, the institution used Treasury funds to pay for 77.0 percent of administrator merit increases, 74.0 percent of faculty merit increases, and 57.0 percent of staff merit increases.

## Fiscal Year 2012 Workforce Demographics<sup>b</sup>


### Summary

Of the institution's administrators, 86.8 percent were 40 years of age and older, and of the institution's staff employees, 61.5 percent were 40 years of age or older. The average length of employment at the institution for administrators was 9.1 years, and for staff employees it was 6.4 years.


### Age: Administrator and Staff
