

# 788 - Lamar State College - Port Arthur

Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.


## Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation increased by 2.1 percent to 209.3 FTEs in fiscal year 2012 compared to fiscal year 2011. As of August 31, 2012, 22.0 FTEs were administrator positions. The institution's 219.6 total FTEs represents a decrease of 27.0 (10.9 percent) in the total number of FTEs since fiscal year 2008.

In fiscal year 2012, 12.4 percent of FTEs were paid from non-Treasury funds. This is a decrease of 16.3 percent in FTEs paid from non-Treasury funds since fiscal year 2008. Only FTEs paid from Treasury funds count against the FTE limitation.




## Employee Turnover<sup>a</sup>

In fiscal year 2012, the total turnover rate for the institution was 17.6 percent. This was higher than in fiscal year 2011, when the total turnover rate was 15.1 percent. The turnover rate in fiscal year 2012 for administrators (8.3 percent) was higher than in fiscal year 2011, turnover for faculty positions (14.3 percent) was lower than in fiscal year 2011, and turnover for staff positions (20.2 percent) was higher than in fiscal year 2011.


### Turnover Rates




### Administrator Separations

### Staff Separations





## Compensation Information<sup>b</sup>


The average salary for staff employees increased by 2.8 percent and for administrators it decreased by 3.1 percent when compared to the average salaries in fiscal year 2011. Compared to fiscal year 2008, salary and benefits expenditures decreased by 11.1 percent.

In fiscal year 2012, the president's salary was \$194,361. Of that amount, approximately 34.0 percent (\$66,083) was paid from Treasury funds. This salary increased from fiscal year 2011, when the president's salary was \$188,700 (approximately 35.0 percent from Treasury funds).


### Administrator and Staff Average Salaries


In fiscal year 2012, the institution reported that it did not provide administrator, faculty, or staff merit increases.

## Fiscal Year 2012 Workforce Demographics<sup>b</sup>


### Summary

Of the institution's administrators, 100.0 percent were 40 years of age and older, and of the institution's staff employees, 67.1 percent were 40 years of age or older. The average length of employment at the institution for administrators was 19.0 years, and for staff employees it was 9.0 years.


### Age: Administrator and Staff
