Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.


Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 15.9 percent to 4,891.6 FTEs in fiscal year 2014 compared to fiscal year 2013. As of August 31, 2014, 87.8 FTEs were administrator positions. The institution's 9,905.9 total FTEs represent a decrease of 1,351.8 (12.0 percent) in the total number of FTEs since fiscal year 2010.

In fiscal year 2014, 51.9 percent of FTEs were paid from non-appropriated funds. This is a decrease of 11.8 percent in FTEs paid from non-appropriated funds since fiscal year 2010. Only FTEs paid from appropriated funds count against the FTE limitation.




Employee Turnover^a

In fiscal year 2014, the total turnover rate for the institution was 14.6 percent. This was lower than in fiscal year 2013, when the total turnover rate was 15.2 percent. The turnover rate in fiscal year 2014 for administrators (11.3 percent) was higher than in fiscal year 2013, turnover for faculty positions (11.3 percent) was lower than in fiscal year 2013, and turnover for staff positions (16.4 percent) was lower than in fiscal year 2013.


Turnover Rates




Administrator Separations



Compensation Information^b


The average salary for staff employees decreased by 0.5 percent and for administrators it increased by 5.9 percent when compared to the average salaries in fiscal year 2013. Compared to fiscal year 2010, salary and benefits expenditures increased by 0.7 percent.

In fiscal year 2014, the president's salary was \$425,000. This salary was unchanged from fiscal year 2013, when the president's salary was \$425,000.


Administrator and Staff Average Salaries

In fiscal year 2014, the institution used appropriated funds to pay for 83.5 percent of administrator merit increases, 93.6 percent of faculty merit increases, and 44.9 percent of staff merit increases.




Of the institution's administrators, 96.1 percent were 40 years of age and older, and of the institution's staff employees, 59.2 percent were 40 years of age or older. The average length of employment at the institution for administrators was 20.3 years, and for staff employees it was 11.4 years.

In fiscal year 2014, 71.9 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.


Age: Administrator and Staff
