Workforce Summary Document Prepared by the State Auditor's Office.

Based on a review of information self-reported by the institution, the following items are worth noting.


Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation remained the same in fiscal year 2014 compared to fiscal year 2013. As of August 31, 2014, 6.0 FTEs were administrator positions. The institution's 202.3 total FTEs represent a decrease of 24.0 (10.6 percent) in the total number of FTEs since fiscal year 2010.

In fiscal year 2014, 12.0 percent of FTEs were paid from non-appropriated funds. This is a decrease of 17.1 percent in FTEs paid from non-appropriated funds since fiscal year 2010. Only FTEs paid from appropriated funds count against the FTE limitation.




Employee Turnover^a

In fiscal year 2014, the total turnover rate for the institution was 5.8 percent. This was lower than in fiscal year 2013, when the total turnover rate was 8.1 percent. The turnover rate in fiscal year 2014 for administrators (15.0 percent) was higher than in fiscal year 2013, turnover for faculty positions (3.1 percent) was lower than in fiscal year 2013, and turnover for staff positions (9.1 percent) was lower than in fiscal year 2013.


Turnover Rates




Administrator Separations

Staff Separations





Compensation Information^b


The average salary for staff employees increased by 0.2 percent and for administrators it decreased by 1.2 percent when compared to the average salaries in fiscal year 2013. Compared to fiscal year 2010, salary and benefits expenditures decreased by 3.0 percent.

In fiscal year 2014, the president's salary was \$200,659. This salary increased from fiscal year 2013, when the president's salary was \$197,694.


Administrator and Staff Average Salaries



Fiscal Year 2014 Workforce Demographics^b


Summary

Of the institution's administrators, 85.0 percent were 40 years of age and older, and of the institution's staff employees, 71.4 percent were 40 years of age or older. The average length of employment at the institution for administrators was 10.0 years, and for staff employees it was 7.0 years.


Age: Administrator and Staff
