

Based on information **self-reported** by the agency, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation remained the same in fiscal year 2016 compared to fiscal year 2015. Compared to fiscal year 2012, the agency saw a decrease of 0.5 (3.2 percent) in the total number of FTEs. While FTE limitations are set for the appellate courts, they are for informational purposes only.




Employee Turnover ^a


Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (17.6 percent) and lower than the turnover rate of Article IV agencies (12.0 percent) during fiscal year 2016. The fiscal year 2016 agency turnover rate including employees who transferred to another state agency or higher education institution was 0.0 percent.



Compensation Information ^a

The average agency salary in fiscal year 2016 of \$86,799 represented an increase of 33.6 percent compared to the average agency salary in fiscal year 2012. In fiscal year 2016, 25.0 percent of employees were paid below the midpoint of the salary range in which they were assigned; and total agency expenditures for salary and benefits were higher compared to fiscal year 2012.



Fiscal Year 2016 Major Occupational Categories




Agency Job Classifications


Fiscal Year 2016 Workforce Demographics ^b

On average, employees at the agency were 51.0 years of age and had 11.5 years of agency length of service. Of the agency's employees, 83.3 percent were 40 years of age or older, and 25.0 percent had fewer than 5 years of agency length of service.


Gender




Ethnic Group

Agency Length of Service



Veteran Employment ^c

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for state agencies of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees effective September 1, 2015.

No veterans were employed by the agency in fiscal years 2015 and 2016.
