

Full-Time Equivalent (FTE) Employees


The agency's full-time equivalent (FTE) employee limitation increased by 16.7 percent to 7.0 FTEs in fiscal year 2016 compared to fiscal year 2015. Compared to fiscal year 2012, the agency saw an increase of 1.9 (38.8 percent) in the total number of FTEs.



Employee Turnover ^a


Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (17.6 percent) and lower than the turnover rate of Article VIII agencies (12.1 percent) during fiscal year 2016. The fiscal year 2016 agency turnover rate including employees who transferred to another state agency or higher education institution was also 0.0 percent.





Compensation Information ^a

The average agency salary in fiscal year 2016 of \$60,630 represented an increase of 7.4 percent compared to the average agency salary in fiscal year 2012. In fiscal year 2016, 42.9 percent of employees were paid below the midpoint of the salary range in which they were assigned; and total agency expenditures for salary and benefits were higher compared to fiscal year 2012.









Agency Job Classifications



On average, employees at the agency were 48.8 years of age and had 4.6 years of agency length of service. Of the agency's employees, 71.4 percent were 40 years of age or older, and 67.8 percent had fewer than 5 years of agency length of service.







Veteran Employment ^c

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for state agencies of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees effective September 1, 2015.

In fiscal year 2016, the agency's total percent of veterans employed is higher than the statewide average and has remained the same since fiscal year 2015.
