

### **Full-Time Equivalent (FTE) Employees**


This agency is a self-directed, semi-independent agency, and as such it has no FTE limitation in the General Appropriations Act. The FTEs listed are paid from non-appropriated funds. Compared to fiscal year 2012, the agency has seen a decrease of 3.4 FTEs (15.2 percent) in the total number of FTEs.



# Employee Turnover <sup>a</sup>


Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (17.6 percent) and lower than the turnover rate of Article VIII agencies (12.1 percent) during fiscal year 2016. The fiscal year 2016 agency turnover rate including employees who transferred to another state agency or higher education institution was 0.0 percent.





#### Compensation Information <sup>6</sup>

The average agency salary in fiscal year 2016 of \$72,363 represented an increase of 25.0 percent compared to the average agency salary in fiscal year 2012. In fiscal year 2016, 32.4 percent of employees were paid below the midpoint of the salary range in which they were assigned; and total agency expenditures for salary and benefits were higher compared to fiscal year 2012.






#### Agency Job Classifications

In fiscal year 2016, the majority (61.1 percent) of employees were classified in the following job titles: Manager (22.2 percent), License and Permit Specialist (16.7 percent), Accountant (11.1 percent), and Systems Analyst (11.1 percent).

## Fiscal Year 2016 Workforce Demographics b

On average, employees at the agency were 51.1 years of age and had 7.3 years of agency length of service. Of the agency's employees, 84.7 percent were 40 years of age or older, and 36.1 percent had fewer than 5 years of agency length of service.








