

## Full-Time Equivalent (FTE) Employees


The agency's full-time equivalent (FTE) employee limitation decreased by 5.4 percent to 7.0 FTEs in fiscal year 2016 compared to fiscal year 2015. Compared to fiscal year 2012, the agency saw an increase of 0.3 (4.6 percent) in the total number of FTEs.



The average agency salary in fiscal year 2016 of \$39,919 represented an increase of 5.8 percent compared to the average agency salary in fiscal year 2012. In fiscal year 2016, 100 percent of employees were paid below the midpoint of the salary range in which they were assigned; and total agency expenditures for salary and benefits were higher compared to fiscal year 2012.
