


Workforce Summary Document Prepared by the State Auditor's Office. Based on a review of information **self-reported** by the institution, the following items are worth noting.

## Full-Time Equivalent (FTE) Employees The institution's full-time equivalent (FTE) employee limitation increased 3,294.5 3,289.3 by 3.4 percent to 1,961.9 FTEs in fiscal year 2016 compared to fiscal year 3,220.7 3.233.9 3,185.9 2015. As of August 31, 2016, 48.1 FTEs were administrator positions. The institution's 3,289.3 total FTEs represents an increase of 103.4 (3.2 1,471.4 1,444.0 1,345.2 1,379.2 1,408.2 percent) in the total number of FTEs since fiscal year 2012. $\rightarrow$ In fiscal year 2016, 43.9 percent of FTEs were paid from non-appropriated funds. This is an increase of 7.3 percent in FTEs paid from nonappropriated funds since fiscal year 2012. In fiscal year 2016, the total turnover rate for the institution was 9.1 percent. This was lower than in fiscal year 2015, when the total turnover rate was 16.1 percent. The turnover rate in fiscal year 2016 for administrators (12.2 percent) was lower than in fiscal year 2015, turnover for faculty positions (6.2 percent) was lower than in fiscal year 2015, and turnover for staff positions (11.0 percent) was lower than in fiscal year 2015.



"Turnover information is self-reported by the institution. Administrator positions include officials holding titles such as president, vice president, chancellor, associate chancellor, assistant chancellor, dean, associate dean, assistant dean, and positions with similar responsibilities. Faculty positions include all faculty regardless of tenure or benefits eligibility. Staff positions include only non-faculty employees who worked at least 20 hours per week for at least 4.5 months.
