
Based on a review of information self-reported by the institution, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation increased by 0.2 percent to 2,407.4 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 70.3 FTEs were administrator positions. The institution's 4,184.0 total FTEs represents an increase of 9.4 (0.2 percent) in the total number of FTEs since fiscal year 2012.

In fiscal year 2016, 42.6 percent of FTEs were paid from non-appropriated funds. This is an increase of 0.4 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.



Employee Turnover a

In fiscal year 2016, the total turnover rate for the institution was 16.4 percent. This was lower than in fiscal year 2015, when the total turnover rate was 16.8 percent. The turnover rate in fiscal year 2016 for administrators (7.0 percent) was lower than in fiscal year 2015, turnover for faculty positions (16.7 percent) was lower than in fiscal year 2015.

The separations for faculty that the institution provided for fiscal year 2012 reflected only a portion of faculty members and are not presented in this document and are not included in the total turnover rate for that fiscal year.



Compensation Information

The average salary for staff employees increased by 4.7 percent and for administrators it increased by 0.2 percent when compared to the average salaries in fiscal year 2015. Compared to fiscal year 2012, salary and benefits expenditures increased by 21.6 percent.

In fiscal year 2016, the president's salary was \$406,291. This salary increased from fiscal year 2015, when the president's salary was \$381,291.

Of the institution's administrators, 100.0 percent were 40 years of age or older, and of the institution's staff employees, 65.2 percent were 40 years of age or older. The average length of employment at the institution for administrators was 17.2 years, and for staff employees it was 9.2 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.

In fiscal year 2016, the institution's total percentage of veterans employed is lower than the state average and has increased since fiscal year 2015.
