
Based on a review of information **self-reported** by the institution, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 0.7 percent to 1,074.7 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 71.9 FTEs were administrator positions. The institution's 1,729.6 total FTEs represents a decrease of 3.1 (0.2 percent) in the total number of FTEs since fiscal year 2012.


In fiscal year 2016, 65.2 percent of FTEs were paid from non-appropriated funds. This is an increase of 66.9 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.







Employee Turnover ^a

In fiscal year 2016, the total turnover rate for the institution was 11.6 percent. This was higher than in fiscal year 2015, when the total turnover rate was 10.6 percent. The turnover rate in fiscal year 2016 for administrators (0.0 percent) was the same as fiscal year 2015, turnover for faculty positions (8.6 percent) was higher than in fiscal year 2015, and turnover for staff positions (13.4 percent) was higher than in fiscal year 2015.












Compensation Information b

The average salary for staff employees decreased by 1.3 percent and for administrators it increased by 0.8 percent when compared to the average salaries in fiscal year 2015. Compared to fiscal year 2012, salary and benefits expenditures decreased by 1.5 percent.

In fiscal year 2016, the president's salary was \$324,740. This salary increased from fiscal year 2015, when the president's salary was \$314,991.

In fiscal year 2016, the institution used appropriated funds to pay for 48.0 percent of administrator merit increases, 96.0 percent of faculty merit increases, and 6.0 percent of staff merit increases.


Totals

Of the institution's administrators, 100.0 percent were 40 years of age or older, and of the institution's staff employees, 63.5 percent were 40 years of age or older. The average length of employment at the institution for administrators was 18.0 years, and for staff employees it was 8.0 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.

In fiscal year 2016, the institution's total percentage of veterans employed is lower than the state average and has remained the same since fiscal year 2015.

In fiscal year 2016, 66.0 percent of faculty FTEs with teaching responsibility were tenured or tenure-track.
