Workforce Summary Document Prepared by the State Auditor's Office.


Based on a review of information **self-reported** by the institution, the following items are worth noting.

#### Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 80.3 percent to 14.1 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 10.0 FTEs were administrator positions. The institution's 59.8 total FTEs represents a decrease of 36.7 (38.0 percent) in the total number of FTEs since fiscal year 2012.


In fiscal year 2016, 76.6 percent of FTEs were paid from non-appropriated funds. This is an increase of 536.1 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.

### **Employee Turnover** <sup>a</sup>

In fiscal year 2016, the total turnover rate for the institution was 15.0 percent. This was lower than in fiscal year 2015, when the total turnover rate was 20.6 percent. The turnover rate in fiscal year 2016 for administrators (0.0 percent) was the same as in fiscal year 2015 and turnover for staff positions (18.8 percent) was lower than in fiscal year 2015.



## Compensation Information b

The average salary for staff employees decreased by 1.0 percent and for administrators it decreased slightly when compared to the average salaries in fiscal year 2015. Compared to fiscal year 2012, salary and benefits expenditures decreased by 8.9 percent.

In fiscal year 2016, the chancellor's salary was \$700,000. This salary was unchanged from fiscal year 2015, when the chancellor's salary was \$700,000.




# Fiscal Year 2016 Workforce Demographics and Veteran Workforce Analysis bc

Of the institution's administrators, 91.7 percent were 40 years of age or older, and of the institution's staff employees, 62.5 percent were 40 years of age or older. The average length of employment at the institution for administrators was 11.0 years, and for staff employees it was 8.0 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.

In fiscal year 2016, the institution's total percentage of veterans employed is higher than the state average and has increased since fiscal year 2015.
