
Based on a review of information **self-reported** by the institution, the following items are worth noting.

Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee limitation decreased by 6.2 percent to 198.3 FTEs in fiscal year 2016 compared to fiscal year 2015. As of August 31, 2016, 5.0 FTEs were administrator positions. The institution's 211.8 total FTEs represents a decrease of 41.0 (16.2 percent) in the total number of FTEs since fiscal year 2012.


In fiscal year 2016, 9.3 percent of FTEs were paid from non-appropriated funds. This is a decrease of 47.5 percent in FTEs paid from non-appropriated funds since fiscal year 2012. Only FTEs paid from appropriated funds count against the FTE limitation.







Employee Turnover ab

In fiscal year 2016, the total turnover rate for the institution was 30.0 percent. This was higher than in fiscal year 2015, when the total turnover rate was 25.7 percent. The turnover rate in fiscal year 2016 for administrators (16.7 percent) was higher than in fiscal year 2015, turnover for faculty positions (25.3 percent) was lower than in fiscal year 2015, and turnover for staff positions (33.3 percent) was higher than in fiscal year 2015.













The average salary for staff employees increased by 7.5 percent and for administrators it increased by 9.2 percent when compared to the average salaries in fiscal year 2015.

In fiscal year 2015, the president's salary was \$128,406. During fiscal year 2016, the separate accreditations and operations of the Texas State Technical College System were merged to form a single college. Consequently, there is a single administration and chief executive across the statewide college. In fiscal year 2016, the provost's salary is \$111,468.

In fiscal year 2016, the institution did not use appropriated funds for staff merit increases. The institution did not award administrator or faculty merit increases.

Of the institution's administrators, 83.3 percent were 40 years of age or older, and of the institution's staff employees, 73.5 percent were 40 years of age or older. The average length of employment at the institution for administrators was 11.2 years, and for staff employees it was 8.2 years.

Senate Bill 805 (84th Legislature) amended Texas Government Code, Section 657.004, to set a goal for higher education institutions of employing veterans in full-time positions equal to at least 20.0 percent of the total number of institution employees effective September 1, 2015.
