
Workforce Summary Document prepared by the State Auditor's Office.  
Based on information **self-reported** by the agency, the following items are noteworthy.

### Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation remained the same in fiscal year 2018 compared to fiscal year 2017. Compared to fiscal year 2014, the agency had a decrease of 0.6 (3.8 percent) in the total number of FTEs.




### Employee Turnover <sup>a</sup>


Excluding interagency transfers, the turnover rate within the agency (0.0 percent) was lower than the statewide turnover rate (19.3 percent) and lower than the turnover rate of Article IV agencies (13.8 percent) during fiscal year 2018. The fiscal year 2018 agency turnover rate including employees who transferred to another state agency or higher education institution was 0.0 percent.



### Compensation Information <sup>a</sup>

The average agency salary of \$78,122 in fiscal year 2018 represented an increase of 13.8 percent compared to the average agency salary in fiscal year 2014. In fiscal year 2018, 65.2 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salary and benefits were higher compared to fiscal year 2014.



### Fiscal Year 2018 Major Occupational Categories




### Agency Job Classifications


## Fiscal Year 2018 Workforce Demographics <sup>b</sup>

On average, employees at the agency were 53.8 years of age and had 13.2 years of agency length of service. Of the agency's employees, 84.0 percent were 40 years of age or older, and 12.0 percent had fewer than 5 years of agency length of service.


### Gender




### Ethnic Group

### Agency Length of Service



## Veteran Employment <sup>c</sup>

Effective fiscal year 2016, Texas Government Code, Section 657.004, sets for state agencies a goal of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees.

In fiscal year 2018, the agency's total percent of veterans employed was higher than the statewide average and had increased since fiscal year 2017.
