

Based on information self-reported by the agency, the following items are noteworthy.

Full-Time Equivalent (FTE) Employees

The agency's full-time equivalent (FTE) employee limitation increased by 3.6 percent to 14.5 FTEs in fiscal year 2018 compared to fiscal year 2017. Compared to fiscal year 2014, the agency had an increase of 5.7 (72.2 percent) in the total number of FTEs.

FTEs Below/Above FTE Limitation




Employee Turnover ^a


Excluding interagency transfers, the turnover rate within the agency (7.7 percent) was lower than the statewide turnover rate (19.3 percent) and lower than the turnover rate of Article I agencies (12.2 percent) during fiscal year 2018. The fiscal year 2018 agency turnover rate including employees who transferred to another state agency or higher education institution was 7.7 percent.



Compensation Information ^a

The average agency salary of \$79,366 in fiscal year 2018 represented an increase of 25.1 percent compared to the average agency salary in fiscal year 2014. In fiscal year 2018, 52.0 percent of employees were paid below the midpoint of the salary range in which they were assigned. Total agency expenditures for salary and benefits were higher compared to fiscal year 2014.

Note: With the exception of the executive director, the average salary is for classified regular, full-time employees only. The agency's executive director position was filled in June 2014 by a temporary contract employee. After a 90-day separation, that employee became the executive director as a full-time state employee. Because the agency did not have a full-time executive director for the full fiscal year, the executive director's salary listed for fiscal year 2014 is the not-to-exceed rate within the General Appropriations Act as of August 31, 2014.



Fiscal Year 2018 Major Occupational Categories




Agency Job Classifications


Fiscal Year 2018 Workforce Demographics ^b

On average, employees at the agency were 51.1 years of age and had 7.7 years of agency length of service. Of the agency's employees, 76.9 percent were 40 years of age or older, and 63.4 percent had fewer than 5 years of agency length of service.


Gender




Ethnic Group

Agency Length of Service



Veteran Employment ^c

Effective fiscal year 2016, Texas Government Code, Section 657.004, sets for state agencies a goal of employing veterans in full-time positions equal to at least 20.0 percent of the total number of agency employees.

In fiscal year 2018, the agency's total percent of veterans employed was lower than the statewide average and had remained the same as fiscal year 2017.
