Based on information **self-reported by the institution**, the following items are worth noting:


## Full-Time Equivalent (FTE) Employees

The institution's full-time equivalent (FTE) employee cap increased by 0.8 percent in fiscal year 2010 compared to fiscal year 2009. Over the past 5 years, the institution has seen an increase of 16.3 (9.9 percent) in the total number of FTEs.

In fiscal year 2010, 23.6 percent of FTEs were paid from other funding sources. This is an increase of 37.1 percent in FTEs from other funding sources since fiscal year 2006. Only FTEs paid from appropriated funds count against the FTE cap.

## Employee Headcount and Turnover<sup>a</sup>

In fiscal year 2010, overall turnover for the institution (9.8 percent) was lower than in fiscal year 2009 (11.5 percent). Turnover in fiscal year 2010 for faculty (1.6 percent) was lower than in fiscal year 2009, and turnover for staff positions (14.7 percent) was higher than in fiscal year 2009.




### Faculty and Staff Turnover

Staff turnover increased from 12.4 percent in fiscal year 2009 to 14.7 percent in fiscal year 2010. Faculty turnover decreased from 9.8 percent in fiscal year 2009 to 1.6 percent in fiscal year 2010. Turnover is based on faculty and staff headcount as of September 2008 for fiscal year 2009 and September 2009 for fiscal year 2010.


### Turnover Rates

## Faculty Separations





## Compensation Information


Over the past 5 years, the average salary for staff employees increased by 30.7 percent, and for administrative employees it increased by 10.4 percent. (Administrative positions include officials holding titles such as Vice President, Dean, Associate Dean, and Assistant Dean.) During that same time period, salary and benefits expenditures increased by 16.3 percent.

In fiscal year 2010, the President's salary was \$171,103. Of that amount, approximately 39.0 percent (\$66,730) was paid from appropriated funds. This is an increase from fiscal year 2009 when the President's salary was \$166,119 (approximately 40.0 percent from appropriated funds).


### Staff Average Salary


In fiscal years 2009 and 2010, the institution reported that it did not provide staff or faculty merit increases.

## Fiscal Year 2010 Workforce Demographics<sup>b</sup>


### Summary

Of the institution's staff employees, 74.3 percent are 40 years of age and older. The average length of employment at the institution for staff employees was 7.0 years.


### Age: Staff
